Question and Answer

Question 1: We have some questions about E-guard cabinet transformers:

- Do you install this accessory?
- Are you going to supply this cabinet? we saw that it could be highest than the transformer
- Do we have to supply until the cabinet interface? (See page 19 of specification 6939-S-11-EG)

Answer: We do not require the transformer to be supplied with the E-guard cabinet (Only the throat shall be on the transformer with the required holes to mount the cabinet)

Question 2: Are all units Mild Steel

Answer: As per specification, construction are to be made of high grade steel plate. The tank shall not be corrugated.

Question 3: Are IFDs required?

Answer: Yes, IFD is required.

Question 4: The 9kV arrester needs to be addressed. 9kV will only protect the unit IF the unit is set to the 6900 voltage. It will NOT protect the unit if they set the voltage to 13800. If the unit is set to 13800 with a 9kV arrester and a catastrophe happens, the unit will fail. Maybe they plan to only set these to 6900, if which they'll be fine. Maybe the 13800 is in preparation for a future update in which they plan to change out the arrester. We have no way of knowing, but need to make sure 9kV is really what they want. And that they understand the risk.

Answer: JPS is award of the unit's protection only on the 6900 voltages for the 9kv arresters. JPS will made changes for the other voltage where required.

Question 5: We check that there is a document that is called "Summary Data Sheet" but at the end of the specification attached, there is another datasheet. Do we have to fill in only the document "Summary Data Sheet"?

Answer: Kindly filled out both sheets
